

INTRODUCTION

Nepal National Social Welfare Association (NNSWA) established itself in 1990. In 1994, NNSWA registered with the District Administration Office Kanchanpur and affiliated to Social Welfare Council Kathmandu. NNSWA has grown over the years, implementing various integrated community-based development programs in Sudur Paschim Province being one of the leading development organizations in the Sudur Paschim Province of Nepal.

NNSWA has 110 General Members who constitute the General Assembly of NNSWA. 11 members of this General Assembly constitute an Executive Committee. Executive Members are elected by the General assembly for a term of 5 years. The Executive Committee has 6 Office Bearers (President, Vice-president, General Secretary, Secretary, Treasurer and Vice-treasurer) and 5 Executive Members. 40% of General Assembly and Executive Committee members are female. NNSWA has its district chapters at Dadeldhura, Baitadi and Darchula districts and other district NNSWA helping committee existed and providing services in all 9 districts within the Sudur Paschim Province, Nepal.

The Executive Committee is the legally constituted body responsible for providing strategic and policy direction to the organization. NNSWA has its own office building having sufficient rooms and training hall at Bheemdatt Municipality-18 in Kanchanpur district.

DEVELOPMENT APPROACHES

Far Western Developmental Region of Nepal constitutes NNSWA's core program areas. The districts of Far Western Developmental Region of Nepal are characterized by poor developmental indicators, high levels of male migration to India, poor infrastructure, vast caste and gender disparity and extensive deforestation, providing NNSWA a rationale for its work there.

NNSWA' program activities are organized into 4 Program Sectors namely, (1) Education and Early Childhood Development (2) General Health and Reproductive Health/Disability Health/Drinking Water and Sanitation (3) Community Development through social and Economic upliftment and (4) Natural Resource Management. The Advocacy and Organizational Development process are inbuilt with all sectors as crosscutting approaches. Each sector is sub-divided into Core Areas. Though NNSWA's programs have been so organized, these categories are not watertight and there is an overlap that reflects NNSWA's understanding of the multi-factorial causation of poverty, lack of access to information and resources, poor health, illiteracy, and advocacy disempowerment and marginalization. NNSWA's programs are almost entirely grant funded. These programs are either directly implemented by NNSWA or in partnership with local organizations. For the implementation of all programs with its working areas, NNSWA has adequate number of skilled and trained staff who has been providing quality service to the target community.

Geographical Coverage

NNSWA was established in Kanchanpur district and started its Community Based Integrated Rural Development. Gradually NNSWA extended its working districts within the Sudurpaschim Province, Lumbini and Karnali Province of Nepal. Currently, NNSWA is providing its various services for community development, physical rehabilitation services, Livelihood Development, Climate Change Adaptation, Humanitarian Response/DRRM, Active Citizenship, human rights and civil society capacity building in the 3 provinces in Nepal directly and indirectly. These projects and programs are mostly implemented through its skilled and trained human resources and other helping committees formed by NNSWA or through collaborative partners in the districts.

PROGRAMS and Projects

Current Projects/Programs (On Going):

(1) **SUDRIDH Project:**

To assist for resilient community on CCA/DRRM and Livelihood, a SUDRIDH project is implementing in Bheemdatt, Dodhara Chadni of Kanchanpur and Parshuram Municipality of Dadeldhura starting from Jan 2022. Covering for the youth and women, cooperatives, networking, farmer groups and other groups for the active participation in livelihood, mitigating DRRM affect and making resilient community is the objective. The project is planned for 5 years from 2002 to 2026. The Municipalities are the major coordinating agencies for collaborating, strengthening capacity and work together strategy will be an approach of the Shudridh project.

(2) Green City (Plantation) Project:

Under the concept of Green City, Clean City concept plantation project is running in Bheemdatt Municipality of Kanchanpur district in Sudur Paschim Province, Nepal. Planting the tree at Bheemdatt Eco-Park, Maintaining the Bheemdatt public park at ward number 18 of Bheemdatt municipality the project has re-activated the public park as was worst situation. Now about 500 people are visiting the park every day. The photo of the Selfie lover and other family are visiting the park. Similarly, the Eco-Park at ward No 18 of the BheemDatt Municipality will be under project implementation and in future this all efforts will give also enforce to complement to the environment protect and Climate Change Adaptation.

(3) HIV and AIDS Project for Migrant and Their Spouses:

Focus to the migrants and their families, testing through CLT approaches and reducing the HIV prevalence is the main objecting. The project is implementing in 9 Local Level (Municipalities) in Kanchanpur district. Counselling, CLT, Support to ART, Distributing of Condoms, coordination with Local Government and Health Facilities for more outreach for the detection of HIV test and rising the prevention of the HIV and AIDS. Project is implementing under the Partnership with Global Fund/Save the Children in Nepal.

(4) EpiC Nepal Project

EpiC Nepal project is implementing in Kailali and Kanchanpur districts starting from October 2020 and will remain till 2024. As a project task NNSWA will identify, reach and engage new, high risk, and hidden/hard-to-reach FSWs, clients of FSWs and other high-risk individuals providing them with a comprehensive package of HIV services based on their needs and preferences. NNSWA has also focus reaching those high-risk people but not self-identified as KPs or not disclosed their KP status, adolescent girls and young women (AGYW), and spouse, sexual/injecting partners, peers, network contacts, and biological children of PLHIV. NNSWA will mobilize peer navigators to identify and reach PLHIV who are not enrolled in antiretroviral therapy (ART) and link with and enroll in ART, and to follow-up in the community for adherence and

retention based on their need, and to offer them a range of options to refer their partners and members of their risk networks to HIV testing. All PLHIV on ART will also be followed-up by peer navigators in the community for adherence and retention based on their need. HIV-negative KPs, PPs and spouse/partners of PLHIV from Kailali district will be offered PrEP. NNSWA has also promote U=U (Undetectable = Untransmutable). NNSWA will conduct stigma and discrimination reduction activities in communities and health care settings and will further strengthen gender-based violence (GBV) prevention through GBV screening and referral from community-based outreach and clinics. NNSWA will strengthen collaboration with state/provincial and local government authorities and non-government stakeholders including CBOs of national networks of KPs and PLHIV to accelerate case finding, early enrollment for treatment, viral load testing, adherence and retention. NNSWA will continue using District Health Information System (DHIS-2)/Mero Data for online and real-time data tracking to allow for continuous monitoring and improvement of program outcomes and will build the capacities of staff including community-based supporters (CBSs) and peer navigators to use data to adaptively manage, focus, and optimize their efforts. NNSWA will also develop and ensure the adherence of data safety and security protocol. Project is implementing under the Partnership with FHI360 Nepal.

(5) HIV and AIDS Project for People with Injecting Drugs (PWIDS):

NNSWA started PWIDs project started in Kanchanpur in 2015 and Kailali district in 2017 and will support to reducing the harm on HIV and AIDS through injecting drug use among the more than 500 IDUs in Kailali and 450 IDUS in Kanchanpur. Almost 950+ people with injecting drug are receiving the service from this project in Kailali and Kanchanpur districts. Project is implementing under the Partnership with Global Fund/Save the Children in Nepal.

(6) Long term Rehabilitation for Disable people

The person with disability who possesses red color identity cards and who have no care taker are rehabilitated in residential rehabilitation center under the economic support of GON-MOWCSW. The rehabilitees person has been receiving all required food, cloths, treatment, accommodations and caretaker within the residential facilities from NNSWA. People Currently 3 persons are taking these services from NNSWA as long-term rehabilitation services. This support is supporting by the GON Ministry of Women Children and Senior Citizen.

(7) Physical Rehabilitation Activity Project:

NNSWA has been implementing support activities to people with disabilities since 1997. From 1997 to 2001 NNSWA provides such support like eye surgery camps, white can support, wheelchair supports and scholarship support to the needy people in the community level. 2002 to 2005 NNSWA implemented CAHD (Community Approach to Handicap in Development) and Disability Inclusion project included various rights-based activities. From 2006 to 2018 the Physical Rehabilitation Center was operating with the financial help of USAID/HI with certain percentage decreasing approaches in every year. Year 2019 was NNSWA PRC was operated with the funding collection of Local Government, Client Service cost payment, Ministry Fund and there was not any financial fund from the INGOs/

Now from the January 2020 NNSWA receiving some financial support especially for the establishing of coordination, awareness rising, meetings and certain percents of budget for non-technical staff and safety/protection material support for the current COVID 19 situation.

The Physical Rehabilitation Services are available in NNSWA as follows.

- I) Prosthesis and Orthoses Services (P&O) with ISPO standard
- II) Mobility Aids (Crutches, Walker, Wheelchair, Tricycle, L-Stick, Special Chairs etc.)
- III) Physiotherapy
- IV) Counseling
- V) Referral

NNSWA has a good experienced human resource (Doctor (P&O Cat-I), P&O Cat-II, Physiotherapist, counselor are available and providing regular services in Rehabilitation Center and Outreach in different Districts.

(8) Assistive Devices Support to PwDs:

Under the financial support from MOWCSC every year, Assistive Devices (Artificial Limbs and Mobility Aids) are manufactured and distributed to the required PwDs in Sudur Paschim Province. These services have been supported in Sudur Paschim Provinces who need assistive devices. After physically checked by

the Physiotherapist and P&O technical person the devices are prescribed for the services from the NNSWA. MOWCSC supports LS amount which is not sufficient but about 50-60 PwDs are benefited with the assistive devices annually.

(9) **DRRM** through Stand by Partnership:

To ready to response during the Disaster in Sudur Paschim Province, NNSWA has been partnering with ACF (Action Against Hunger) as stand by Partnership approaches. As partnering with ACF, if any DRR related incident occurred in Sudur Paschim Province the support will be provided as humanitarian response aspects after receiving actual information about the DRR incident. NNSWA needs to be prepared all verified information and support required for the victims of DRR incident and supporting mechanism and submit to the ACF for channelizing the support under the stand by partnership mechanism.

(10) Promoting Community Engagement and Sponsorship Programme (PCESP)/Inclusive Quality Education Project:

Promoting Community Engagement and Sponsorship Management Programme (PCESP) and Inclusive Quality Education Technical Programme (IQE) has been implementing under Goal of Children are Loved, Protect and Empowerment and Improved Equitable Access to Inclusive & Quality Education for most vulnerable Children at Basic Level (up to Grade -8) in Kanchanpur District under the Partnership with World Vision International Nepal.

(11) M-RED Project:

Managing Risk through Economic Development (M-RED) believes in nexus between economic development and disaster preparedness that could response positively reinforce each other. M-RED has a vision that communities will be better and able to recover from recurring shocks and stresses over time. M-RED has been implementing in vulnerable communities in Kanchanpur district under partnership with Mercy Corps Nepal.

(12) Leprosy and social inclusion

To make accessibility in every aspect of the People with social inclusion approaches the project is aim to initiate a Inclusive Governance of Local Level with the coordination and collaboration mechanism regarding barrier free in all aspects such as physical, economic, political and societal prospecting project is initiating with "Outcome Mapping" approaches were expecting of all stakeholders will be participated with their expertise and resources. Similarly, project is implementing to stop the spreading of Leprosy in all 9 Districts of the Sudur Paschim Province., with close coordinating and collaborating of regional and district health offices for the stop leprosy transformation. The project is focusing to 1) Leprosy Program (Zero Transmission), 2) Prevention of Impairments and Disabilities ('Zero Disability'), and 3) Leprosy and social inclusion (Zero Exclusion).

(13) NPL INTPA Quality Education: Leaving No One Behind Project:

NNSWA implementing this project in Jajarkot, Kalikot and Kanchanpur Districts focusing to the schools, CSOs, Networking, Child Clubs, Youth Networking and OPDs for improving the inclusive education and establish a model school for inclusive education at least 1 school in a project implementing Municipality. The working Municipalities are, Bheri, Chhedagad in Jajarkot, Tilagufa, Shubhakalika in Kalikot and Laljhadi, Beldadi in Kanchanpur districts. The project was started in April 2024 for 42 months funded by EU and partnering with Save the Children International.

(14) Advocacy and Social Mobilization to strengthen Birth Registration Management System (BRMS) to Promote Timely Birth Registration in Kailali District of Nepal

Under the objective of Strengthen Civil Registration System Particularly Birth Registration in Local Government and Availability of Quality Data in Kailali district of the Sudur Paschim Province of Nepal. A cornerstone of the BRMS project is its focus on raising awareness about the importance of birth registration, NNSWA has conducted extensive awareness campaigns aimed of educating parents and communities on the benefits and legal requirements of timely birth registration for their children. The project's multiphase approach includes facilitating and to reach unreached areas, conducting awareness campaigns and building local capacity, for digital birth registration system. The project was partnering with GIZ under the Support to the Health Sector Strategy (S2HSS).

Completed Projects/Programs: (Major)

(1) Education and Early Childhood Development

NNSWA implementing the education and early childhood development program with the close collaboration and coordination of District Education offices. The program was implanted separately such Basic Education (BE), early childhood development (ECD) and Non-Formal Education (NFE). Following are the brief details of these programs. The education and early childhood development programs was implemented with the financial and technical support from the Save the Children USA from 1994 to 2011.

a) Basic Education (BE)

Basic education program is a core program, which has been implemented for the radical change of existing quality of education in Kanchanpur district. This program also aims to increase the access in education and develop the support systems and policy of Basic education. Activities that implemented under Basic Education

- 1. Enrollment Campaign
- 2. Ensure education support from government to eligible and needy children
- 3. Paid Volunteer Teacher Support
- 4. Child Friendly School (CFS) Assessment and Package programming

- 7. School Improvement Plan (SIP)/School Self Assessment (SSA) Workshop
- 8. Parents Teachers Association Support
- 9. School Management Committee Strengthening
- 10. Peace Education Training
- 11. District Level SZOP Declaration for learning without fear workshop
- 12. Emergency Education Response Program during disaster

b) Early Childhood Development (ECD)

The Early Childhood Development Program (ECD) which is the regular program with the community centered. As per the aim of the program, efforts of ECD Program are being focused and continued on increasing access to ECD programs; enhance knowledge, attitudes and skills of caregivers, and enhance the ability of parents to promote the optimal development of their young children's education. As always, this program also tries to give support and supplement to the program of the District Education Office (DEO). NNSWA fully implements the 98-community based ECDs and 20 school based ECDs with the collaboration of district education office of government in Kanchanpur district. The activities under this program are as following.

- 1. ECD center establishment and strengthening (community based, pre-primary class, mobile ECD centers)
- 2. Ensure basic health service in ECD center
- 3. ECD facilitator basic/refresher training and Quarterly meeting
- 4. ECD Transition program
- 5. ECD Parenting Education
- 6. ECD center maintenance/construction support
- 7. Flooring support to ECD center
- 8. ECD kit material support to CBCDC and school based ECD center
- 9. ECD network formation at VDC/Municipality and orientation
- 10. Orientation to VDC/Municipality personnel for ECD registration
- 11. Orientation to DCDC (District Child Development Center)
- 12. Emergency Education Response Program during Disaster

c) None Formal Education (NFE)

NNSWA has experienced implemented on none formal education such as Basic Adult Literacy classes, Advanced Adult Literacy classes, Language Learning/Experience classes, Participatory Learning Approach

(PLA), REFLECT Circles, Out of School Children education, Child-to-Child Education, Parental Education, Life skill education and BLOP.

(2) Health and Reproductive Health/Disability and Health/Drinking Water and Sanitation

The Health and Reproductive Health/Disability and Health/Drinking Water and Sanitation programs was implemented with the financial and technical support from the Save the Children USA from 1994 to 2011. This sector is combing with the various health related project/programs are described as following.

a. School Health and Nutrition

School Health and Nutrition Program is being implemented in Kanchanpur district. This program is targeted to the school- aged children of between 6-18 years. NNSWA has planned to implement school health and nutrition program by making a comprehensive school-based program. The activities under SHN programs are as following.

- 1. Coordination and collaboration with District Public Health Office (DPHO)
- 2. Iron tablets supplementation.
- 3. De-worming/Albendazol
- 4. Referral Support for health treatment
- 5. First aid training and material support
- 6. SHN education and cleaning demonstration session
- 7. Toilets and pump functioning follow up
- 8. Waste disposal ring Pit follow up
- 9. WASH education to teacher and students
- 10. Health Focal Teacher Training
- 11. Review and reflection meeting with Focal Teacher/ Health Teacher.
- 12. Weighting Machine Support
- 13. Joint Monitoring by district stakeholders

b. Adolescent Reproductive Sexual Health (ARSH)

NNSWA has been implementing Adolescent Development Program in Kanchanpur since 1996. Various child club centered activities related to adolescent of ages between 10 to 18 years are conducted through participatory approach. Among other activities, the specific intervention implemented is Adolescent Reproductive & Sexual Health (ARSH) in 176 Child Clubs covering over 10,000 adolescents (school going and out of school) of ages 10 to 18 years. NNSWA has created and developed the concept of 'Bal Samaj' or "Child Societies" within the framework of the United Nations' Child Rights Convention to increase the participation of children in community development. The Adolescent Development Program has been focused to implement various activities such as child club formation, promotional activities, child citizenship and governance, economical education, child journalism and various other activities. Following are the few activities implementing under Adolescent Reproductive Sexual Health (ARSH).

- 1. Adolescent-Friendly Services
- 2. Peer Education and Counseling
- 3. Teacher Training
- 4. WASH Orientation to Child Clubs
- 5. Information, Education, and Communication (IEC)
- 6. Adult/Parent Education
- 7. Youth Development
- 8. Aware on Social Norms
- 9. Economic Livelihoods
- 10. Out Reach Clinic (ORC)

c. Drinking Water and Sanitation

NNSWA has been implementing Water and Sanitation (WATSAN) program in School of Kanchanpur district in collaboration & coordination with District Public Health Office (DPHO) and District Education Office (DEO). WATSAN program has been planned with clear objectives and vision guided by WATSAN module. The target group of this program is primary school age children (6-14 yr.). School Health and Nutrition (SHN) and Water and Sanitation (WATSAN) Program is being implemented. This program is targeted to the school- aged children of between 6-14 years of 115 Schools within the impact areas.

(3) Arsenic Mitigation Program

In Kanchanpur district few VDCs are found under water contaminate of ARSENIC. Laxmipur, Daijee, Suda, Shankarpur, Sripur VDCs are found with water contaminated that seen arsenic. Daijee VDC is among these VDC and NNSWA has started Arsenic Mitigation and Sanitation Project with close collaboration of Dajee VDC and local beneficiaries. Following activities under this project is implementing:

- Distribution of arsenic filters to selected households;
- Construction of sanitation/household latrines;
- Construction of village drainage; and
- Construction of platforms for dug wells
- WASH education session to community

(4) Bhashi Small Town Water Scheme

Under Small Town Water Supply and Sanitation Sector Project (STWSSSP-II), a total of 12 towns have been selected for the implementation of first batch. The STWSSSP-II project will take the services of one local NGO for each town to provide support for (i) socio-economic analysis and resettlement; (ii) inclusion of poor and disadvantaged sections as well as gender mainstreaming through the implementation of Gender Equality and Social Inclusion Implementation Plan in the project activities including delivery of output-based aid (OBA); (iii) community awareness and people's participation in project activities; (iv) health and hygiene education with WASH; (v) community based participatory solid waste management; and (vi) capacity building of WUSCs and WUAs for operational sustainability etc.

Based on the demand of the community people, Bhasi Small Town Water Supply and Sanitation Sector Project has been selected and undertaken among 12 towns for the implementation under first batch. The project has been envisaged to serve parts of ward numbers 1, 2, 3, 4, 6 and 18 of Bheemdatt Municipality and some part of ward number 8 of Suda VDC (adjoining VDC of Municipality) in Kanchanpur District of Mahakali Zone in Far Western Development Region of Nepal

(5) Comprehensive HIV and AIDS Program

NNSWA has been working on HIV and AIDS program since 1993 targeted to the migrant population, transport workers, school students, force personnel and female sex workers initially. In far western region NNSWA is the pioneer organization who implemented the HIV and AIDS awareness project on 1993 with the financial support of American Foundation for AIDS Research (AmFAR) and technical support of Save the Children. From the 1993 till to date NNSWA has been implementing HIV and AIDS program with different funding agencies for providing comprehensive package to the migrant population.

NNSWA has recently complete the ASHA project both prevention and IHS project in Kanchanpur and Kailali with the technical and financial support of FHI 360. NNSWA has got the expertise on the successfully implementation of HIV prevention programs among migrants and their spouses in Kanchanpur districts. NNSWA implemented USAID funded ASHA project of HIV prevention component from October 2006 to Sep 2011. NNSWA has largely integrated HIV/AIDS and STI prevention into all its activities looking this is one of the developmental issues that need an integrated multi-sectoral response.

NNSWA in collaboration with Indian organizations both at the border with India and further into India, in Uttarakhand State had implemented a small pilot cross-border initiative that targets Nepali male migrants to India at the transit points and receiving (destination) areas. The Uttaranchal Development Institute (UDI), Savdhan at Banbasa and Arohi at Kumau in India are the partners for this cross boarder initiatives. This cross boarder initiative will supplement its activities targeting male migrants and their spouses in the origin (Nepal) areas.

At presently, NNSWA is implanting a comprehensive HIV and AIDS program including prevention of HIV and AIDS, Family Planning awareness and linked for facility, CHBC, VCCT in Kanchanpur and Kailali districts. NNSWA have equipped VCCT Center in Kanchanpur and Kailali where skilled and trained experienced staffs are delivering the services to the people in need.

(6) Community Development through social and Economic upliftment

To upliftment of poor and marginalized community NNSWA has been implementing the economic development activities related to the income generation, agricultural and livestock, skill development, cooperatives, self-help groups and other related networking. Under this sector NNSWA have experience on following program/projects.

a) Cooperative Management Support

To sustain the economic regularity and reduce the local loan and high interest among the village level NNSWA support to the community people to organize through the cooperative for financially sustained. Right now, NNSWA assist to establish various cooperative in the Freed Kamaiya community. A Milan Agriculture Multipurpose Cooperative Organization in Andrajhala Dekhatbhuli DVC and Krisi Bahuudasya Sahakari Santha in Shovatal Sripur VDC. These both cooperative are implementing all activities and have good amount of financial resource and almost all agriculture inputs. Likewise, in other cooperatives are under the PAF program is formed and operating smoothly. In this sector we also initiated the youth cooperative in Jhalari VDC considering the poor youth for their economical development.

b) Agriculture/Vegetable Farming

The scope of agriculture and vegetable farming is high in the region. So NNSWA supported the farmers for their agriculture development by providing the seeds and saplings. Rice and Wheat seeds were distributed more than 15000 farmers for seed production. Likewise, more that 15000 household were received the vegetable seed for kitchen and business farming of the vegetable.

Formation of farmer's groups and support mechanism is established for sustainable agriculture. NNSWA also supported the develop village health worker by providing 15 days to 90 days months VHW training and support to them for establish the agro-vet shop in the village level. Most of the beneficiaries are from the Dalits, Disabled and Deprived community.

A partnership between NNSWA and Actionaid Nepal was implemented the both A and B project from 1997 to 2006.

(7) AAMA Project – Kailali district

NNSWA has implementing AAMA (Action against Malnutrition through Agriculture) project in Kailali district from the year 2009 under the financial support of USAID/Helen Keller International Nepal (USAID/HKI). The aim of this project is to develop an integrated food security and nutrition district wide model that can be adapted and taken to scale up in other areas of Nepal in order to reduce malnutrition and morbidity in under-two year's children and pregnant and lactating women. Inclusive breastfeeding, ANC and PNC education and ensuring the using of all required immunization both mother and child, using of health facilities and attending the child birth in health institute are the major activities of the projects. In addition it also aims to enhance the skill of FCHVs on various health related subject through ENA (Essential Nutrition Action) packages. Under this project following activities are implementing.

- 1. Homestead Food Production (HFP) Training for District Agriculture Officers and staffs
- 2. Village Model Farm Maintenance Training for FCHVs
- 3. Essential Nutrition Action (ENA) and Behavior Change Communication (BCC) training of trainers (TOT) for NGO and district health and agricultural staff and FHCV supervisors and FCHVs
- 4. Training for Members of Mothers Groups
- 5. Co-ordination with DDC, DPHO, DAO, DLSO
- 6. Implementation of social mobilization activities with community groups

(8) Natural Resource and Disaster Risk Management

NNSWA's working areas covers almost all VDCs of Kanchanpur district and running various programs within the Far Western Region. A significant part of the district is under low land areas. Nearly every year they suffer from floods caused by Mahakali, Chaudhar, Banara, Baibaha rivers. Many people were vacated from Shuklaphanta Wildlife Reserve forest during the course of extension of Wildlife Reserve and they have not been given land by the government and living nearby forest in thatched houses. Every year during summer their houses gutted in fire and they become distressed by severe reduction in their access to food, shelter, water and sanitation, medical care as well as by fear and uncertainty. Children, in particular, suffer additionally from lack of care and protection against abuse and violence. Nepal National Social Welfare Association (NNSWA) has been involved in post flood relief, fire victim, and resettlement, rehabilitation and recovery program in Kanchanpur district. Flood is the biggest natural disaster that holds the lives of many people and losses of

cultivated land and property every year. Other natural and manmade disasters are fire, wildlife victim also forcing people into displacement. Threats come mainly from:

- Floods which often destroy people's houses and household assets and force them into displacements,
- Landless people living inside the forest often vacated by the government, and
- Fire victims mostly poor people who are living in the thatched house and vulnerable of fire catch.

Under the close partnership with multiple INGOs and donor agencies NNSWA has been working in the field of disaster. Under this we are supporting to the District Disaster Risk Reduction Committee (DDRRC) in district level to develop the district disaster preparedness plan and support to the victims as needed during and post disaster. NNSWA is also working as a cluster member in Education, Health and Water, Protection, None Food Item.

Currently NNSWA is implementing following activities under Community Based Disaster Risk Management (CBDRM) and Child Centered Disaster Risk Management (CCDRM) projects. The CCDRM is focused to the child centered disaster risk reduction and CBDRM is focused to the person with disabilities.

- 1. Support to develop Finalization/review of district disaster preparedness or contingency plan;
- 2. Training to DDRC/district level stakeholders and DDRC cluster on child protection issues;
- 3. Safe space and WASH training to education cluster (teachers and child club members);
- 4. Formation of village level district level relief committee and training on protection;
- 5. Training to FCHVs on water, sanitation and hygiene and mobilized FCHVs for WASH education to disaster prone areas;
- 6. Developing heightening water shad, renovation and repair of water source of disaster prone areas of the district
- 7. Broadcasting of disaster and WASH related awareness message through FM.
- 8. Support for river train (bamboo piling)
- 9. Established community rescue group with materials (Life Jacket, Rope, Tube, Wooden boat)
- 10. Establish stock piling of disability assistive device for mitigation the risk at community level
- 11. Support to function local early warning system
- 12. Distribution food and none food item s during rescue, Health education and treatment support in rescue camp
- 13. Preparation of DRR plan in schools and VDCs;
- 14. Construction of retaining wall and bio-engineering in disaster prone areas of the VDCs

(9) Kamalahari practices Abolition

Kamalahari practices are suited in Dang, Bardiya, Banke, Surkhet, Kailali and Kanchanpur District. In Kanchanpur according to survey data there are more than 1000 Kamalahari which is worst form of child labor. To abolish this practice NNSWA is implementing Kamalahari practice Abolition project in partnership with Plan Nepal from 2010 to 2015. It is five years project and its main goal is to abolish this practice within five years. Project is delivered in three aspects such as Gender and child rights (Awareness), Learning program and livelihood program. To abolish this practice above three aspects are very essential. This project will be implemented with the following approaches;

- 1. Community participation and mobilization
- 2. Capacity building of community groups
- 3. Collaboration and coordination with likeminded organizations
- 4. Advocacy and lobby
- 5. Awareness of anti group (Kamalahari using group)
- 6. Sustainable Support Package for Kamalahari
- 7. Legal Support to Kamalahari

Under this project following are the major activities and implementing

- 1. Rescue Kamalahari girls with the support of District Administrative Office
- 2. Develop Network against the Kamalahari
- 3. Provide scholarship to Kamalahari girls
- 4. Provide coaching and tuition facilities to Kamalahari girls
- 5. Create learning without fare environment at school
- 6. Support income generating program for Kamalahari and their families
- 7. Develop cooperative among Kamalahari family.

- 8. Provide life skill education
- 9. Health and Hygiene

(10) CAAFAG/VM/LR Program

NNSWA has been works for the support under the Reintegration of CAAFAG/VM/LR Program in Kanchanpur district. Under this program, fifty persons are involved in different activities such as skill development and school education programs. It package program and support package is described according to the UN. NNSWA provides counseling, motivating to the eligible persons are as VM/LR for getting the support as defined by the UN. The fund was supported by UNCEF through Save the Children.

(11) Voter's Registration Education Campaign

Targeting to the freed Kamaiya community in five districts of mid far western region, NNSWA has been providing voter's registration education. About one lakh thirty-six thousand 16+ population are living in Kanchanpur, Kailali, Bardiya, Banke and Dang known as freed Kamaiya Community. These communities are called Tharu community originally. The voter's registration project educates to the community about importance of voters registration and political rights of there as citizen of the nation. The project mobilized the Tharu community staffs who know the all about their community. Home visits, Group education, mentoring/facilitating for making citizenship, educating the process for voter's registration with photo, IEC promotion and close coordination with the district election office for as much as big proportion will register in the district. The financial supported was made from USAID through IFES.

(12) CBDRM-SAFER Project

Focusing to the Early Warning System in ward no. 1, 2 and 3 of Shankarpur VDC, in Kanchanpur district NNSWA has implementing the CBDRM with the partnership with Mercy Crops/EC. To establish the early warning system and support to raising the awareness for minimizing the risk of disaster by flood.

Establishing river gage, siren and training to the community people associated with different taskforce such as first aid, rescue, food security and other related to the disaster and mitigation.

(13) CBDRM-VISTAR I and II Project

NNSWA has been working in disaster prone VDCs of Kanchanpur focused flood disaster and river land slide, silt deposit on agriculture land. Making local level policies such as LDMRP and other VDCs level action plans are developed under project supports.

Local structures are formed and capacitated with different trainings regard to the disaster in Kanchanpur district. Currently NNSWA and HI/EC partnership is focusing in 5 new VDC and 4 old VDCs in Kanchanpur district. Develop CDMC, task Forces and mitigation supports are the major activities of the project.

(14) Creating Community Hub for Interaction in Mahakali Basin (CSF: SAWGP).

NNSWA has made an agreement with The Asia Foundation-Nepal as non-lead partner for "Creating a Community Hub for Interaction in Mahakali Basin" on September 1st 2016 under the civil society fund: South Asia Water Governance Project (CSF: SAWGP). Under this project has a prime objective to "Creating Community Hub for Interaction in Mahakali Basin" and following were the major activities:

- 1. Establishment Interactive Hub
- 2. Coordinating networks/forums/community groups, Hub, Steering Committee
- 3. Creating knowledge tools and opportunities for interaction and articulation
- 4. Institutional Development Activities (Interacting & building a knowledge groups/practitioners)
- 5. Quarterly Team Meeting (4 meetings in Banbasa and Mahendranagar)
- 6. Confluence Conclaves (5 CC in Mahakali River Basin)
- 7. Documenting Valleys, Develop Framework for field work and Start Assessment
- 8. Research and Interaction with technical Experts and Community

The Project has reached with;

Male: 260 Female: 50 Total: 310 through Confluence Conclave, Male: 8 Female: 4 Total: 12 through Key Informers Interview: Male: 499 Female: 128 Total: 627 through Community Assessment. In total 949 individuals' participants (Male: 767 and Female: 182) were participated directly for this Creating Community Hub for Interaction in Mahakali Basin project directly. A community assessment report that documented about the expectation of the Pancheshwar Multipurpose Project (PMP) belonging communities of Dadeldhura, Baitadi and Darchula district of Nepal. The project has able to raise the voices of communities regarding to the PMP and their responsibility for the victims as well as Indo-Nepal boarder issues.

(15) Sajhedari Bikaas Project (WEG)

NNSWA Kanchanpur is a sub award partner for Sajhedari Bikaas Project (WEG) for implementing the planned activities in 29 VDCs of Kanchanpur and Kailali Districts for Phase 1st and 2nd commence from March 15th 2014. Support to empowering local women's groups to access, mobilize, and strategically use resources for equitable and effective development.

To create an improved enabling environment for the community development through addressing the local level conflicts, promoting economic activities, and amplifying the voices and decision making abilities of women, youth, and marginalized groups. NNSWA has been taking a leading role in creating a sustainable and low-cost program for women that fosters grass roots development, increasing family income and local control of resources. Sajhedari Bikaas Project (WEG) was implemented partnership with PACT World International and funded by USAID.

(16) Sajhedari Bikaas Project (Local Governance)

NNSWA Kanchanpur is a sub award partner for Sajhedari Bikaas Project (Governance) for implementing the planned activities in 8 VDCs of Kanchanpur District for phase 1st and 2nd commence from February 15th 2014. The project approach brings together a combination of strategic interventions with communities, civil society, private sector and government. These include improving the enabling environment for local development, strengthening inclusion and participation of communities and marginalized groups, supporting the economic empowerment of marginalized groups, and improving the accountability and transparency of local government.

To promoting the development process including marginalized community in every development process through the local governance with meaningful participation of the historically excluded communities of selected 8 VDCs in phase 1st and 2nd of Sajhedari Bikaas project. Sajhedari Bikaas Project (Local Governance) was implemented partnership with PACT World International and funded by USAID.

(17) Malaria Mobile Clinic (MMC)

Detection of malaria infections in the community will require some form of community testing. The implementing of malaria mobile clinics (MMCs) is in the community level will be rolled out throughout the high and moderate risk wards during the malaria season. This community based diagnosis and treatment service may yield better results due to increased access to diagnosis and treatment and early detection of cases and immediate and complete effective treatment in the community. Early diagnosis and effective treatment will ensure minimal chances of onward malaria transmission in the community. This project is running in Kanchanpur, Kailali and Bardia with close coordination of DPHOs. Malaria Mobile Clinics (MMCs) was funded by Global Fund through Save the Children.

(18) CBR Program

Under the financial support from Women Children Office, NNSWA providing various supports services to people living with disabilities in Kanchanpur district under CBR Program. The support is being utilized as subsidy to the Physical Rehabilitation Center of NNSWA.

- Trainings to VDRC groups on planning and assessment
- Assistive devices support
- Matching fund support to VDRC groups for income generation activities
- Stationery and dress support to CWDs students

The project was supported by the Ministry of Women Children and Social Welfare (MoWCSW) Nepal.

(19) Physical Rehabilitation Services to Person with Disability

The actual data on disability is not available yet but very soon the national senses 2011will declare the data about the disability in Nepal. According to the WHO, the 10% of person with disable are living in the Nepal. According to this percentage more than 26000 Person with Disable (Physical) are living in the Far Western Region of Nepal.

NNSWA has been implementing the support activities to the person with disable from 1997. During 1997 to 2001 NNSWA provides such support like eye surgery camps, white can support, wheel chair supports and scholarship support to the needy people in the community level. 2002 to 2005 NNSWA implemented CAHD (Community Approach to Handicap in Development) and Disability Inclusion project included various rights-based activities.

Leading by these above community-based experience on disability sector NNSWA, started Physical Rehabilitation Services by establishing a Physical Rehabilitation Center in Bheemdatt Municipality of Kanchanpur District with the financial and technical support of the Handicap International-Nepal. Currently; NNSWA implementing the CBR (Community Based Rehabilitation) program and Physical Rehabilitation Services in the Far Western Region of Nepal since 2006.

The Physical Rehabilitation Services are available in NNSWA is as following;

- I) Prosthesis and Orthoses Services (P&O) with ISPO standard
- II) Mobility Aids (Crutches, Walker, Wheelchair, Tricycle, L-Stick, Special Chairs etc.)
- III) Physiotherapy
- IV) Counseling
- V) Referral

NNSWA trained the staff for both P&O and Physiotherapy. A disable friendly hostel is serving to the clients during their treatment in the center. 12 beds and kitchen, disable friendly toilet and other infrastructure are available in the Physical Rehabilitation Center of NNSWA. From its establishment period to till of date more than 15000 people are benefited. These services are provided through the center base and outreach activities (Disability Assessment Mobile Camps) in the districts. NNSWA conducted disability mobile camps in all districts of Far Western Region and supported to the desired supportive devices to the person with disability.

NNSWA has also close working relations with the orthopedic hospital in Kathmandu and in other regional based hospitals. NNSWA referral for minor corrective surgery among these related hospitals for surgery purposes. Basically, club feet, fracture and burn case are focused for this referral mechanism. NNSWA refer to the surgery clients to the hospital and after surgery all devices and take care is provided by the NNSWA. NNSWA also organized the Surgery Camp in District level to serve the remote area's needy people for the services. For this NNSWA arranges the human resources from national level hospital especially for orthopedic surgeons included all camp team and conducted the surgery camps in the districts.

The financial support by the USAID through Handicap International was from 2010 to 2018 under Physical Rehabilitation Services for the all 9 district of the Far Western Region of Nepal.

(20) Inclusion Project

The financial support by the USAID through Handicap International was from 2010 to 2018 under Disability Inclusion Services for the Kailali district of the Far Western Region of Nepal.

(21) Poverty Alleviation Program (PAP)

Almost 70,000 population is from the Dalit community and more than 5,000 families are freed Kamaiya and more than 4,000 are the Suklafanta evacuated families are resided in Kanchanpur. Based in view of the poverty condition of the 7 VDCs (Dodhara, Chadani, Suda, Daijee, Pipaladi, Jhalari and Krishnapur) and Municipality of Kanchanpur district NNSWA started the poverty alleviation project as an innovative program to reduce the acute poverty funding by PAF. The main objective of Poverty Alleviation Fund (PAF) and similar as NNSWA is to reduce the level of poverty this program is implementing in the district. The main components of project are (I) Social mobilization; (ii) Income generation; and (iii) Capacity Building and (iv) Support for infrastructure Development. Currently, 2441 Kamaiya HH, 830 Dalits HH, 138 from Shuklafanta evacuated households and 167from other community are involved in the PAF program and covered 19848 populations. As of now the following income generation services have been provided to a total of 2,820 families within the targeted areas of Kanchanpur district under the PAP program: Under this project following activities are implementing.

- 1. Livestock raising (Buffalo, Goat, Ox, Pigs, Cow, etc)
- 2. Poultry and Fisheries, Retail shops
- 3. Bicycle and motorcycle repairing training
- 4. Knitting and Weaving
- 5. Agriculture farming (off-season vegetable and mushroom)
- 6. Need identification training for micro-finance
- 7. Market management training
- 8. Livestock management training
- 9. Formation of 151 Savings and 120 IGP implementations groups
- 10. Community awareness on water, sanitation and hygiene sector
- 11. Support to infrastructure development (Irrigation, Water, River band and Road)
- 12. Pocket program:
 - a. Mass Potato Farming
 - b. Piggery
 - c. Poultry
 - d. River Belt Vegetable Farming

(22) PWIDS and CCC Project

NNSWA has been working in PWIDs cluster including community care centre (CCC) for the PLHIVs in Kanchanpur district. To reduce g the harm among the drug injecting person on HIV and AIDS a community-based test is implementing and provide syringe exchanging facility, condoms and counseling for people is being implemented. Almost 400+ people with injecting drug are receiving the service from this project. The PLHIVs who need the special care and support during the ART, PMTCT and nutritional aspect, a CCC is established and providing the supports under the prescriptions of the doctor. The children who are living with HIV infection are receiving cash as support for the schooling and nutrition foods at home. +/- 55 children are receiving this facility in Kanchanpur district. The capacity of CCC is to accommodate 10 people in one time. A heath team is taking care all of indoor PLHIVs with medicine, accommodation and fooding supports.

(23) Suaahara -1 Project

Suaahara integrated nutrition program seeks to improve the health of pregnant and lactating women and children less than two years of age. Suaahara is a comprehensive community-focused program that integrates

various sectors-nutrition, hygiene and sanitation, agriculture and health services promotion in order to address the key factors affecting nutritional status. In other words, Suaahara is on the way of paving path to reach target group-1000 days (Pregnant and Lactating Mother) households. Suaahara is accelerating to create amiable environment for smooth operation of the program.

(24) Strengthening Community Resilience in Rangun Khola and Lower Mahakali Watersheds (PANI Project)

This project seeks to address the issues of watershed degradation particularly due to causes of destructive fishing practices and local water management in Rangun Khola and Lower Mahakali watersheds by building the capacity of community and local elected bodies. This project will develop a Sustainable Capture Fisheries Guideline; assess the existing status of LAPA/CAPA, LDRMP, WUMP; support local communities in replicating the watershed management best practices; and, enhance capacity of the local elected leaders on aquatic biodiversity conservation and gender equity and social inclusion in planning processes.

(25) CS: MAP (Civil Society: Mutual Accountability Project

The Civil Society: Mutual Accountability Project (CS: MAP) is a five year project (April 2016-April 2021) supported by the United States Agency for International Development (USAID) and implemented by FHI 360. CS: MAP's goal is to foster a more legitimate, accountable, and resilient Nepali civil society that can advance the public interest. CS: MAP will make its efforts to building an enabling environment by providing various capacities building trainings, techniques, and process to the Civil Society Organizations and Media in Local level for better engagement with government services and policy implementation in all level of the development process. Both development actors' civil society organization and Governmental organization will have close coordination and collaboration to inform the citizen for the changing process of the nation positively. The community level social structures, political structures, public private structures and legally accepted structure will enhance their knowledge and responsibilities for the public service oversights and contribution by engaging to the services.

Under this award, NNSWA as CS: MAP's ISO partner, will coordinate and facilitate CSOs, Local Public Authorities of GoN and private sectors. The NNSWA will facilitate the CSOs for developing networking, peer learning sharing, advocacy for policy governance and implementation, mainstreaming GESI and public service oversight.

(26) RESILIENT LIVELIHOODS AND SUSTAINABLE FOOD SECURITY

Initiating with two VDC (Belauri and Laxmipur) of Kanchanpur district the RESILIENT LIVELIHOODS AND SUSTAINABLE FOOD SECURITY project is implementing from Nov 2013. This project will support to make resilient community in livelihood and sustainable food security as well as for climate change and adaptation. Basically marginalized community such as freed Kamaiya, Dalits are the major targeted community and focused to disaster vulnerability communities. The Dan Church Aid (DCA) is the financial partner for this project in Kanchanpur. Sripur and Laxmipur VDCs are to be the starting VDCs for this project.

Further After developing or maximizing of development activities under integrating Resilience Livelihood, Active Citizenship, HR/DRR and Agro-ecological Farming adopting of Climate Change in 3-5 wards of Belauri Municipality, DCA/NNSWA CBLSFS project is implementing from 2017.

(27) Linkages Nepal Project (HIV and AIDS Project)

NNSWA will identify, reach and engage new, high risk, and hidden/hard-to-reach FSWs, clients of FSWs and other high-risk individuals providing them with a comprehensive package of HIV services based on their needs and preferences. NNSWA will also focus reaching those high-risk people but not self-identified as KPs or not disclosed their KP status, adolescent girls and young women (AGYW), and spouse, sexual/injecting partners, peers, network contacts, and biological children of PLHIV. NNSWA will mobilize peer navigators to identify and reach PLHIV who are not enrolled in antiretroviral therapy (ART) and link with and enroll in ART, and to follow-up in the community for adherence and retention based on their need, and to offer them a range of options to refer their partners and members of their risk networks to HIV testing. All PLHIV on ART will also be followed-up by peer navigators in the community for adherence and

retention based on their need. HIV-negative KPs, PPs and spouse/partners of PLHIV from Kailali district will be offered PrEP. NNSWA will also promote U=U (Undetectable = Untransmittable).

NNSWA will conduct stigma and discrimination reduction activities in communities and health care settings and will further strengthen gender-based violence (GBV) prevention through GBV screening and referral from community-based outreach and clinics. NNSWA will strengthen collaboration with state/provincial and local government authorities and non-government stakeholders including CBOs of national networks of KPs and PLHIV to accelerate case finding, early enrollment for treatment, viral load testing, adherence and retention.

NNSWA will continue using District Health Information System (DHIS-2)/ Mero Data for online and real-time data tracking to allow for continuous monitoring and improvement of program outcomes and will build the capacities of staff including community-based supporters (CBSs) and peer navigators to use data to adaptively manage, focus, and optimize their efforts. NNSWA will also develop and ensure the adherence of data safety and security protocol. Project is implementing under the Partnership with FHI360 Nepal.

(28) **SAPHAL Project:**

This project was previously implemented as Resilience Livelihood Sustainable Food Security (RLSFS) and after 7 years (From 2020) implementing as SAPHAL project in Belauri Municipality of Kanchanpur District. Extending livelihood support through a smart ecological agriculture (Farm and Off farm) among the marginalized communities (Tharus, Migrants, Landless and Dalits) about 3000 families are directly involve for agro based livelihood activities combining with groups and cooperatives. Supporting to the women cooperatives through the business literacy and promoting markets for the production of their members. Project is implementing under the Partnership with DCA Nepal.

(29) UTHAN Project:

This project has been implementing from 2020 to 2022 in Laljhadi Rural Municipality and Belauri Municipality focused in Livelihood activities and DRR Management. Tharus, Dalits, Disables, returnee youths and other marginalized communities are the beneficiaries for the project. Capacity building of the local CSOs in planning process, participation in local level development and advocacy to the local government for budget allocation appropriately as need. Project is implementing under the Partnership with DCA Nepal.

(30) Disaster Emergency Response Fund (DERF):

NNSWA has recently working on DERF project focusing on COVID 19. Supporting to the Palikas for managing 7 quarantines, 3 isolations, support health protection equipment for 9 Palikas and IEC/BCC materials. NNSWA also supported 1500+ families a foodstuff packages under the Palikas coordination focusing to Disability, pregnant women, displaced community and other marginalized in 5 Palikas of Kanchanpur districts.

(31) ACT Alliance Global Response to the COVID-19 Pandemic

Project is implementing in 3 Municipalities (Bheemdatt Municipality, Belauri Municipality and Laljhadi Rural Municipality) of the Kanchanpur Districts. Support the Municipality for managing Health Help Desk, Support to COVID 19 survivors during isolating, Support to Survivors for their income generating activities and mobilizing of the FCHVs for response to the COVID 19.

(32) Study/Assessment on Migrant Returnees

NNSWA has conducted an assessment of Migrant returnees due to Covid 19 impact in Kanchanpur to know the skills, their interest for self-job in locally. NNSWA did the interview with 690 returnees of Bheemdatt Municipality, Laljhadi Rural Municipality and Belauri Municipality of the Kanchanpur. This assessment report will support the Municipalities for developing a plan of action as self-employment or local job to the returnees within the Municipality. This report is describing about skills, interest and capacity for the self-employment within the Municipality or in the district. The study/assessment was conducted with the technical support from the DCA Nepal.

(33) Fish Farming:

NNSWA has supporting livelihood support to Tharu, Landless/Migrant people, Dalits by constructing support of Fish farming in Laljhadi and Belauri Municipality of Kanchanpur district. 5 groups are existing covering with about 260 families. Project is implementing under the Partnership with DCA Nepal.

(34) Mushroom Farming:

15 groups of marginalized communities are growing Mushroom every year in Belauri Municipality seasonally. A group earned more than 2 to 3 lakh per seasons. Project is implementing under the Partnership with DCA Nepal.

(35) Compression Brick Production:

We are going to implement a compression brick factory targeting to returning youths in Laljhadi and Belauri Municipality of Kanchanpur. Project is implementing under the Partnership with DCA Nepal.

(36) Suaahara -2 Project

Suaahara integrated nutrition programme is started again as Suaahara 2 project through the USAID fund and HKI lead mechanism where NNSWA is a partner organization in Kanchanpur district from 2026 to 2022. The project activities were as previous Suaahara-1 project implementing approaches but emphasis for the more capacity strengthening of government health facility and focus to the GESI within all component. Multi sector involvement and working together practices is more empowering the targeted 1000 days female (Pregnant and Lactating Mother) and their families. Project is implementing under the Partnership with HKI and Care Nepal.

(37) Disability Inclusive Development/LPEP and My village Model Village

To make accessibility in every aspect of the People with Disability with DID approaches the project is aim to initiate a two "Model Village" in Kailali and Kanchanpur is started from November 1st 2015 and completed in 2020. With the coordination and collaboration mechanism among the DPOs, Local Government and National for making "Model Village" regarding barrier free in all aspects such as physical, economic, political and societal is prospecting. For the initiating this novel model village concept NLR is taking the lead role and NNSWA and other DPOs are doing their role as boundary partners. The project is initiating with "Outcome Mapping" approaches were expecting of all stakeholders will be participated with their expertise and resources program boundary partners. NNSWA has been working with 6 Municipals for their inclusive development planning process through online database systems. NNSWA also implementing the stop leprosy transmission through a LPEP project in province number 7 supported by NLR and close coordination with District health facilities.

(38) **Inclusive Development:**

Support to the Palikas for Inclusive Development from the planning phase, managing the DATA base, increasing the meaningful participation from the marginalized community and good governing practices are the focus within the project. For the NNSWA has agreement with 6 Municipalities (Kanchanpur: Suklaphanta, Laljhadi and Beldadi and Kailali: Gauriganga, Kailari, Bardagoriya). Started in 2018 and completed in 2022.

(39) Stop Leprosy:

This project is being implemented in all 9 Districts of the Sudur Paschim Province to stop the spreading of Leprosy. Coordinating and collaborating with Regional and district health office and testing leprosy and 1st hand medication are the roles of NNSWA. Started in 2018 and completed in 2022.

(40) ECHO-IOM COVID 19 Response and Preventive Project:

The objective of the project is to provide safe and regular crossing for migrants amid COVID-19 by improved capacity of isolation centers and ground crossing points. Strengthen the overall capacity of the health-based facilities through provision of crucial equipment and human resources. The safety of migrants and personnel at GCPs Crossing Points) and isolation centers will be ensured through provision of safety gears and medical equipment, provision of semi-permanent health desks to support health screening and testing to meet anticipated high influx of return migrants, and supporting the provincial governments in developing contingency plans for public health emergencies. Personnel will be trained on the use of safety

gears; medical equipment will be provided. The project will support through provision of technical equipment including tablets and computers as well as solar panels at targeted isolation centers and GCPs to strengthen reporting and recording mechanisms, COVID19 screening and referrals, and logistical management.

(41) **Be-Ready Project:**

A functional, impact-based forecasting mechanism is in place to enable anticipatory action at Dodhara Chandani municipality of Kanchanpur District. Ready to the community, local government (Municipality), Youth and other supportive team are trained, policy in place and early action plan in hand are major task to overcome the any disaster (Especially Flood) response through this project. Equipped LEOC and other safeguarding gears are in place with close coordination and collaboration of the Municipality. Risk informed community/house and using the early financing for the risk mitigation also in practices in the project.

Advocacy as a Cross Cutting Approaches

Advocacy towards the Rights Holders:

NNSWA has been doing the advocacy to the concerned sources for its focused target communities. To claim the rights and equity NNSWA assist to the communities and individuals. NNSWA also supporting to the target community and general population for their voting rights, constitutional rights and other human rights as when needed. NNSWA has been also supporting to the collecting the views and their advice of target community and general population for building the constitution in Nepal. Following are the focus issues that, NNSWA has been advocated.

1. Rights of Discriminated Community by Caste (DALIT)

The Nepalese Hindu Religion has four major categories of castes: Brahmin, Chhetriya, Baisya, and Shudra. The fourth caste Shudra is known as the Dalit or untouchable caste in Nepal. (*Nepal Constitutional is untouchable fee nation but in practice this happening*) The first three castes dominate and discriminate against the Shudra caste. The Far Western Region of Nepal is not immune to the discrimination of Dalits. Due to the structural disparities in the caste system, the Dalit people are educationally, economically and socially found backwards. The Dalit people are not allowed to enter in Hindu temples, are not allowed to use public water sources, and hotels/restaurants. This type of discrimination and inhuman behavior practice prevails in Nepal but in Far Western Region is the most affected. Therefore, NNSWA advocates for Dalit Human Rights. NNSWA files cases in the court for the rights of the citizen when caste issues cannot be resolved at the community level. NNSWA's priority is to educate to the Dalit community. NNSWA facilitates and supports education, economic opportunities, and social advocacy, empowers their social voice in Government activities, and increases Dalits knowledge of health and sanitation.

2. Rights of Freed Kamaiyas

The Government of Nepal declared abolition of bonded labour on July 17, 2000 in the country and all bonded labour were debt free from their landlords. This declaration occurred through the advocacy of Nepal NGOs and Kamaiyas. NNSWA played a vital role in this freedom movement. Now the government relocated Freed-Kamaiyas and provided one to five Katha of land to each family. NNSWA has worked with Freed-Kamaiyas by building low cost housing, providing nutrition through kitchen garden and poultry farms, health and sanitation, emergency health treatment, water, education, advocacy and empowerment for their human rights.

NNSWA is putting its effort to protect their rights on socio economic and political. To protect their political rights NNSWA educating them through the voter's registration in whole freed Kamaiya camps.

3. Victims from Shuklaphanta Wild Life Preservation

More than 4,000 families were relocated after the expansion of Suklaphata Wild Life Preservation Park. The expansion of the park required previous inhabitants to move from the area. Among the victimized families, 50% were Dalit alone. These families are living near the roadside belonging to forestry department of Government. The conditions of these families are very poor. Almost all children are malnourish, experienced dysentery and skin disease. They are unable to feed their children properly. Majority of Children are out of

school. They are using river water which is contaminated and unhealthy. Hygiene and sanitation situation is also very poor. NNSWA supports these communities by providing hand pumps for drinking water, plastics for shelter, and health treatment through health camps. NNSWA advocates to the government for these victims requesting for their proper rehabilitation and relocation.

4. Rights of Disabled People

The actual data on disability is not available yet but very soon the national senses 2011will declare the data about the disability in Nepal. According to the WHO, the 10% of person with disable are living in the Nepal. According to this percentage more than 200000 Person with Disable are living in the Far Western Region of Nepal. Almost all disabled are not able to effort to survive with better live. The economic condition of this region is not good. Most of people are migrated to India for earning money.

Most of families of the disabled are from the poor community and marginalized. The families are not able to rehabilitate to the disabled by supporting assistive devices or artificial limbs. Any types of service center to support disable people are not found in the Far Western Region of Nepal. Disabled people are depending either in India or another Developing Region in Nepal. Due to the poor financial condition the people of disabled are compelled to survive without any rehabilitation options.

Therefore, NNSWA has been advocating for the rights of the disabled people. NNSWA trained staff works with a community-based approach to minimize the discrimination of Disabled people. Physical therapy, assistance devices and treatment are being supported by NNSWA. Also, it has been putting efforts to support disabled people through Physical Rehabilitation Center in Mahendranagar. This is the only one center and covering all 9 districts in Far Western Region of Nepal. In addition, NNSWA has recently constructed Disable Friendly Hostel having 12 beds with attached bathrooms, one kitchen cum dining room. This hostel is providing services to those clients who are coming from remote areas for a certain period of time.

5. Rights of Children

NNSWA works on child development activities by implementing the UNCRC Child Rights in the communities. NNSWA has been facilitating holistic development for children through child clubs, and adolescent reproductive sexual health program. NNSWA advocates against child labor and girl trafficking a well as Kamalahari. NNSWA has been looking for the children who are facing political conflict in Kanchanpur district and putting efforts for the reintegration.

6. Rights of People Living with HIV and AIDS (PLHIVs)

NNSWA has been working on HIV/AIDS program since 1993 in Kanchanpur District. NNSWA supports to People Living with HIV and AIDS (PLWHA) and their families with the HIV/AIDS Impact Mitigation Program. Palliative Care, Home Base Care, Treatment of Opportunist Disease, Counseling, Support to the children for schooling are major activities for the PLWHAs. NNSWA advocates anti-discrimination against PLWHAs. NNSWA is also providing income generation training to PLWHAs for their better livelihood.

Organizational Development (OD)

NNSWA was established in 1990 and has been gradually stepping towards institutionalizing by organizational development process. NNSWA has been demonstrating its strong organization operating system to run an organization by providing quality services to the target community with cost effective and efficient. NNSWA believes that, the development of both project side and organizational side should be managed parallel and equally. So NNSWA has been practiced in Organizational Development (OD) process regularly. NNSWA is improving internal OD and support to other local NGOs for their OD.

A. Internal OD Process of NNSWA:

- 1. Organizational Assessment: NNSWA conducts organizational assessment in every year and developed plan of action for improving the situation.
- 2. Five Year Strategic Plan: NNSWA has been developing the projects and program through organizational five years strategic plan.
- **3. External Audit:** NNSWA has been doing the external audit by recruiting an independent qualify auditor for auditing the all-financial transaction of NNSWA.
- **4. Social Audit:** NNSWA has been conducting a social audit for NNSWA's projects and program in yearly basis.

- **5. DPAC/MPAC Meeting:** NNSWA in every twice a year conducting the District Project Advisory Committee (DPAC) meeting and present the all-project progress and planning for the next six months. The meeting is chaired by Local district Officer (LDO) and all district stakeholders are participated as members.
- **6. Annual All Staff Meeting:** NNSWA has been conducting all staff meeting on annual basis. Where all could introduce each other and all projects are sharing about the best practices, lesson learnt to each other and trying to find out synergy within the NNSWA implementing projects.
- 7. **Annual Staff Appraisal:** To managing the quality services and effective implementation NNSWA has been doing the staff's appraisal in each complete year. The appraisal gives an effort to enhance the capacity of staff as well as capacity of organization.
- **8. General Assembly:** NNSWA has been general assembly in every year and present the progress and financial report to the assembly. In every five year there is convention and an election is held for new executive committee for next five years.

B. External Support for OD by NNSWA

- 1. Capacity building support to Local NGOs: NNSWA has been support to the local NGOs in the districts for their OA; develop strategic plan and human recourse plan from the year 2004. NNSWA also support them as per their request on OD process. NNSWA had a good experience on organizational Development which acquired from the 5 years long project implanted in Nepal called "Strengthening NGO Sector in Nepal" (SNSN). Under this project NNSWA support to the 8 local NGOs in Mahakali Zone as Intermediately Support Organization.
- 2. Collaboration for Projects: NNSWA has been implementing such projects with collaboratively and also looking the opportunity to work jointly by producing the joint proposal and developing the networking in locally.

NNSWA is committed to work together with GOs, I/NGOs and other agencies to reduce the poverty, severe malnutrition, improving the agro base production, promoting animal husbandry, and reducing the vulnerability of HIV and AIDS, Care and Support programming to PLHIVs and reducing the climate change and possible hazard and disasters. Promotion of green enterprises and livelihood options with women and youth empowerment.
- 3. Promotion of Physical Rehabilitation facilities in Sudurpaschim Province of Nepal by expanding the services from the Center to all districts of far western region.
- 4. To be the lead NGO for integrated development of all nine districts of the Far Western Development Region in collaboration and co-ordination with Bilateral/Lateral Agencies, HMG/N, INGOs, local NGOs, Private sector, Individual and CBOs.
- 5. Rights based programming focusing on *Discriminated Community by Caste*, *Disables*, *Deprived* (Freed *Kamaiyas*, PLWHAs and other marginalized groups/communities).
- 6. To create a cadre of well trained and committed young Nepali men and women who will assist and facilitate their communities in the Far Western Development Region of Nepal to attain their full potential for development. Promoting the safe migration and protection.
- 7. NNSWA has been working in disaster preparedness activities in Kanchanpur district which is basically limited to response it needs to focus more on preparedness and mitigation by addressing adverse effects of climate change.
